



The Committee noted the Extracts of the Academic Council meeting held on 21.10.2014 in reference to Item No.4 under "Any Other Item":-

"Dean of Colleges intimated that no norms have been prescribed for teachers on adhoc basis in the affiliated colleges for the purpose of evaluation of answer books. As it is a serious issue, therefore, a Committee will be constituted to look intro the matter "

It was brought to the notice of the Committee that the guideline for spot Evaluation of answer books has already been got approved by the Vice-Chancellor. The Committee discuss the matter in detail and after due deliberation the Committee made the following recommendations which may be included in the guidelines of Spot Evaluation of answer books of U.G/P.G./Engg. :-

- The evaluation work may be got done by the Coordinators in the Spot Evaluation Centre in order of following preference:
 - Regular teachers having three years experience in the concerned (i)
 - If regular teachers are not available, the full time contractual teacher having (ii) minimum three years teaching experience in their subject concerned in any affiliated colleges may be appointed for evaluation of answer books.
 - The teacher who will take the answer book bundles from the concerned (iii) colleges will have to submit from his/her Principal certifying that he/she is having three years of experience in teaching profession in the subject concerned in the affiliated college/institute as required for evaluation.
- All the examination duties have been made manadatory for all teachers as per letter 2. Memo.No.18/1/2011 UNP (4) dated 101.3.2011 received from Assistant Director UNP, Office of Higher Education Commissioner, Haryana, Panchkula circulated to all the Principal of the affiliated Colleges/Directors of various Institutes by Secrecy Branch of this University vide Endst.No.SAO/OS-1/SA-I/4224-4657 dated 29.3.2011 (Copy enclosed).
- Each examiner shall be required to evaluate at least 20 answer books in each session 3. i.e. Morning & Evening session.

- It was also brought to the notice of the Committee that Executive Council vides its Resolution No.26 dated 1.12.2014 has approved rules for the inspection/certified photocopy of the evaluated/re-evaluated answer book. Accordingly, the Coordinator(s) may please advise/instruct the teachers concerned evaluating the answer books to be more vigilant while evaluating the answer books. Besides in the past, some omissions of totaling and unmarked questions were survived in the evaluating answer books which were pointed out by the students after inspecting their answer books. Therefore, it needs to be ensured that there remain no such omissions, particularly in view of the fact that a Checking Assistant also carries out necessary checking for which the Checking Assistant is also paid remuneration.
- Dr.Jagdish Gupta, Principal, Arya (PG) College, Panipat pointed out that there is no provision for Securitymen in the Spot Evaluation Centre of College/Institute whereas the services of Securitymen in Spot Evaluation Centre are essentially required. Also, that the remuneration paid to non-teaching employees of Class-III & Class-IV is very meager. Principals were also been raising this issue from time to time. It is, therefore, recommended that the Coordinator of the Spot Evaluation Centre may be authorized to engage one Securityman from his/her college/institute on a fixed remuneration. Further the remuneration of Class-III & Class-IV employee may also be revised. Therefore, the Committee recommends the following remuneration to Class-III & IV employees:





- (ii) On-Line-Admission: The following suggestions were made:
 - If a college is providing additional facilities like internet to the students, it should be allowed to charge proportionate extra fee.
 - College should be allowed to charge additional fee from the students against the unfilled sanctioned posts.
 - College should be allowed to charge additional funds from the students for other compulsory / mandatory expenses like Property Tax/ House Tax etc.
 - College fee structure for Government/Aided Colleges should be finalised only after consultation with the Representatives of the Principals.

(iii) Charging Fee from SC Students

• Letter should be written to the University and DGHE that University should not charge University fee for SC students from colleges & this amount should be transferred directly to university by the Government.

(iv) Three months salary in lieu of notice period

The matter was discussed and it was unanimously decided that the association should take up the matter with the concerned authority on priority basis.

- (v) Regarding online process for the submission of salary and pension bills. It was decided that the matter should be urgently taken up with the DHE.
- (vi) Remoneration of Supdt.-in- Chief

A letter should be written to Kurukshetra University, Kurukshetra that the Remuneration to Supdt,-in-Chief should be on the pattern of M.D.U.

The meeting ended with a vote of thanks to the host college.






